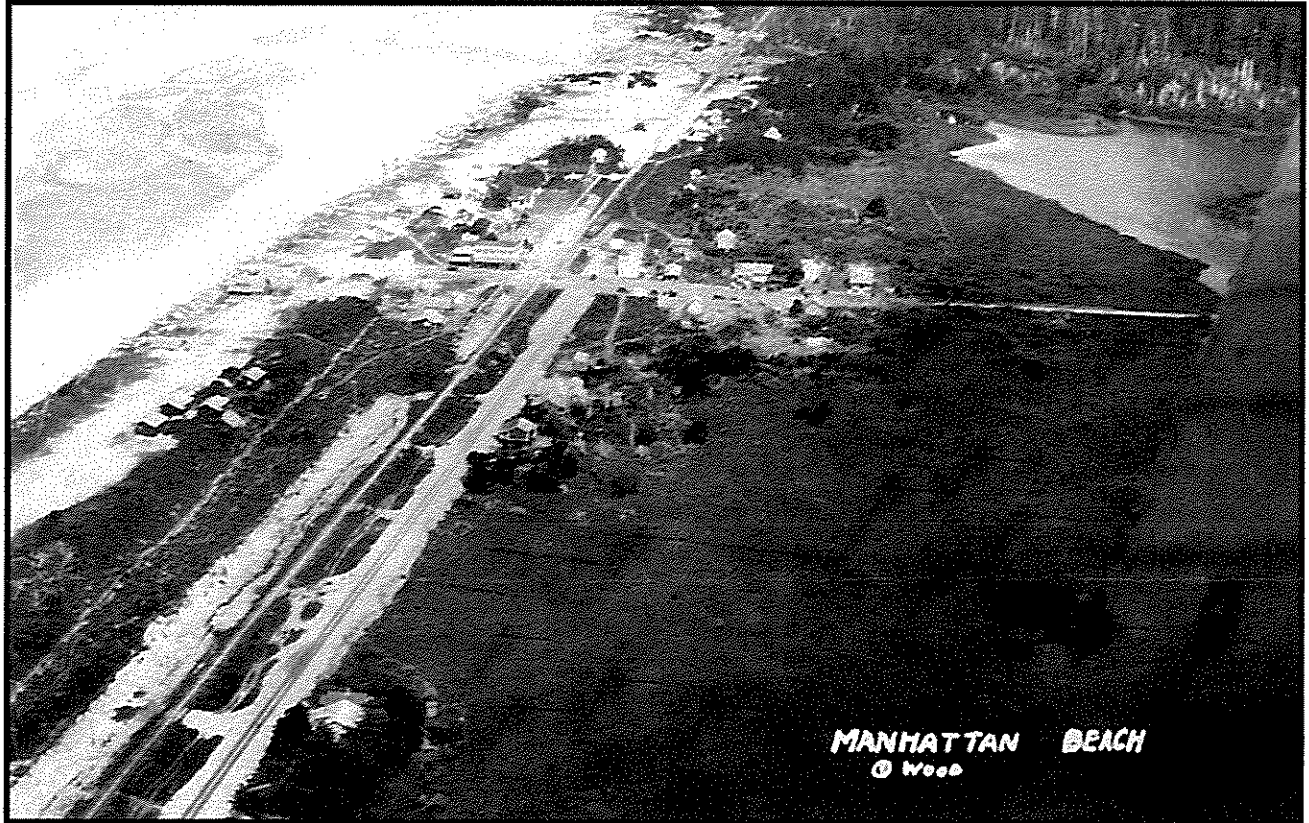

Manhattan Beach, Oregon

Manhattan Beach, Oregon is the northernmost of the five communities that have had post offices on the seven miles of ocean beach between Tillamook and Nehalem bays. This beach was originally known as Garibaldi Beach, but has since become known as Rockaway Beach. The five communities with post offices, from south to north, are Bar View, Twin Rocks, Rockaway Beach, Lake Lytle and Manhattan Beach. Only the Rockaway Beach post office still operates.

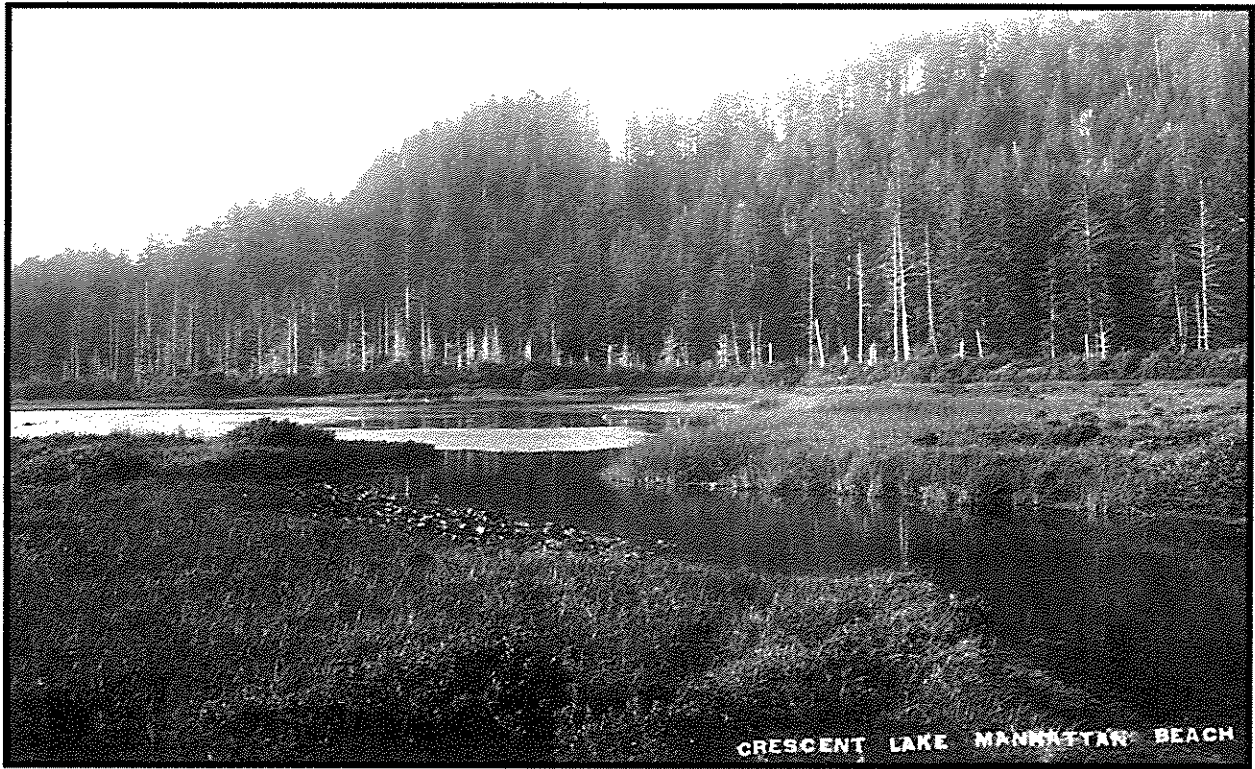
Manhattan Beach was an unincorporated community, originating from several homesteads that were developed upon the arrival of the Pacific Railway & Navigation Co. (PR&N) railroad, which was completed in 1911. The original developers called the subdivision Manhattan.

The Manhattan subdivision lay between the middle of what is now NW 18th & 19th avenues and 24th Avenue, situated between Crescent Lake and the ocean beach. In 1910, the PR&N Co. built a small depot to be used as a flag station at 19th Avenue. In 1912 the Crescent Hotel was built adjacent to the depot. Grace Huston and her daughter took charge of the hotel in 1914. On September 3, 1914, Grace I. Huston was appointed postmaster of the new Manhattan Beach post office. Located in the Crescent Hotel, the office opened for business on September 5, 1914. Manhattan Beach became a popular destination once the railroad made it accessible. The PR&N offered a round trip from Portland to the Tillamook beaches for \$3.00.

Grace Huston was the Manhattan Beach postmaster in the Crescent Hotel for over 20 years. When she became ill, her daughter Doris performed the postal duties. Following Mrs. Huston's death in July 1935, the hotel was sold. Mrs. Doris M. Pickett was appointed postmaster effective July 27, 1935. Mrs. Pickett moved the post office across the highway (now U.S. 101) to her home and business, the Bungalow Grocery. Eight years later Mrs. Ada B. Gillam was appointed postmaster, effective July 1, 1943. She served 32 years. At some point a one-room post office was built across the highway on the footprint of the Crescent Hotel, which had been demolished. The post office went through several re-designations, but remained at this site until it closed.

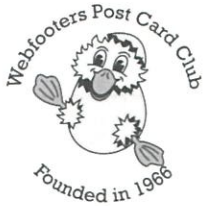

Manhattan Beach post office was discontinued as a 4th Class office on March 15, 1954, the same date as the Bar View and Twin Rocks post offices were closed. And like Bar View and Twin Rocks, the next day it reopened as a Rural Station of Rockaway, with no interruption of postal service. Manhattan Beach Rural Station was redesignated a Community Post Office (CPO) on July 1, 1972. The office was permanently closed on July 1, 1975, with all mail going to Rockaway. A residence now occupies the location of the last Manhattan Beach post office site.

Manhattan Beach voted to annex to the city of Rockaway Beach in 1974. With a blend of permanent and vacation homes, Manhattan Beach now looks like the rest of Rockaway Beach. Most of the housing is on the ocean side of U.S. 101, with plenty of beach access, including The Oregon State Parks' Manhattan Beach Wayside.
